

Regulations of the promotional action "WRITE AN INTERPRETATION FOR OUR NEW MOTTO!"

§1 General provisions

1. The organizer of the competition is JJPM Sp. z o.o., ul. Rzeczycka 26, 04-940 Warsaw, NIP: 952 212 66 67.
2. The prize is funded by the Organizer.
3. The competition is not created, administered, or sponsored by Facebook/Instagram. Facebook/Instagram is not responsible for any actions related to the organization of the competition on their platforms.

§2 Participation conditions

1. Only adults can participate in the competition.
2. Participation in the competition requires having a verified account on Facebook/Instagram.
3. The competition runs from 01.03.2024 at 20:00 to 30.03.2024 at the end of the day.
4. The results will be announced on 31.03.2024 at 20:00.
5. The competition takes place through the fan page on the social media platform Facebook at <https://www.facebook.com/adblpolska> and Instagram at https://www.instagram.com/adbl_official/.

§3 Competition task

1. The competition task involves writing an interpretation of the ADBL motto in a comment on Instagram/Facebook.
2. One winner will be selected in the competition, and consolation prizes are provided for 10 people.
3. The most interesting and best interpretation will be chosen by the competition commission consisting of 2 people.
4. Winners will be notified of their victory and prize collection conditions via private message on Facebook or Instagram.
5. The Organizer emphasizes respecting the creativity of others and maintaining a cultural tone in expressions.
6. Entries containing vulgarities and inappropriate words will be removed and will not participate in the competition.

§4 Prize

1. The main prize is a package of car care products and accessories worth no less than 1000 PLN gross, at catalog prices. Consolation prizes are packages of cosmetics or cosmetics and accessories worth no less than 100 PLN gross per set, at catalog prices.
2. The prize can be received by mail.
3. The Organizer has the right to disclose the Winner's data on the fan page.
4. The Organizer is not responsible for the inability to deliver the prize due to reasons on the Participant's side. In such a case, the prize is forfeited.
5. The Organizer is not responsible for incorrect data provided by the Participant, especially for changes in personal data preventing the location of the Participant and notification of the prize.
6. In case of detecting actions contrary to the Regulations, an attempt to influence the selection of the Winner in an unauthorized manner, especially by creating fictitious profiles on Facebook/Instagram, the participant may be excluded from the competition.

2. Regarding the processing of personal data, please contact the Data Protection Inspector.
3. Personal data will be processed for the purpose and to the extent necessary to conduct the competition, based on art. 6 para. 1 lit. b of the Regulation (EU) 2016/679 (GDPR). The data were collected by the Facebook fan page at <https://www.facebook.com/adblpolska>.

4. Personal data will be processed for the time necessary to conduct the competition, including awarding the prize and announcing information about the winner (and other awarded individuals), and stored until the expiration of any claims or the expiry of the obligation to archive data under the law.

§7 Final provisions

1. Matters not regulated by these Regulations are subject to the provisions of the Civil Code and other legal regulations.
2. Disputes related to and arising from the competition will be resolved by the common court competent for the organizer's registered office.
